*HB 3681, Open Enrollment, enacted by 2011 Legislature, sunsets effective July 1, 2019. The Oregon Department of Education has advised school districts not enroll students through open enrollment for the 2019-20 school year. As described in ORS 339.133, any student who has transferred into a district through open enrollment prior to the 2019-20 school year will maintain their transfer status. Bend-La Pine Schools will continue to consider, and when practical, approve inter-district transfer students as described in administrative policy JECB-AP: Admission of Non-Resident Students.*
