Independent Study / Alternative Learning Experience for Credit

Students may develop and propose learning experiences independent of the regular school curriculum and are asked to follow the following steps:

1. The proposal for alternative credit shall be developed under the guidance and approval of a counselor or supervision teacher in the subject area for which credit will be awarded. Preference should be given to the licensed staff member who will assess the learning gained under the plan.
2. The student shall complete and present the Independent Study / Alternative Learning Experience Proposal form and supplemental information as stated in the form to a review committee consisting of the school administrator in charge of alternative credit options, the supervising teacher, the student's counselor and other personnel as designated by the school administrator. This committee shall approve the proposal and award final credit and grade based on the student's submission of required documentation of performance.
3. The student must show that the alternative credit learning experience is part of the student's educational plan.
4. The proposal and subsequent assessment of learning shall describe the activities, length of time, and the on or off campus supervisor's monitoring plan. The proposal shall also describe the products the student will submit as evidence of meeting performance standards for the class for which alternative learning credit is being requested.
5. Students are encouraged to enroll in a full schedule of classes (no open periods). An approved alternative learning experience may be designated as independent study and scheduled as a class period if it benefits the student's learning.
